

• The further schedule regarding deposition of fee and document verification will be uploaded in the due course of time.

- The candidates who have joined on the allotted seats in the first round of counselling shall have to give their willingness/option to upgrade themselves in the second round of counselling online otherwise they shall not be considered eligible for the second round of counselling.
- The candidates, who have already registered themselves for the first round and wish to participate in the second round, shall not be required to register again. The candidates who have got their document verification done during the first round of counselling are not required to get documents verified again.
- Already registered candidates can change their category or any other information in their already submitted application during Round-1 of counselling.
- The candidates who have been allotted seats in the first round but did not join the allotted seat will also have to give their willingness to participate and submit fresh choices for the second round.
- The Candidates who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if he/she gets an upgraded and opted seat during second round. 

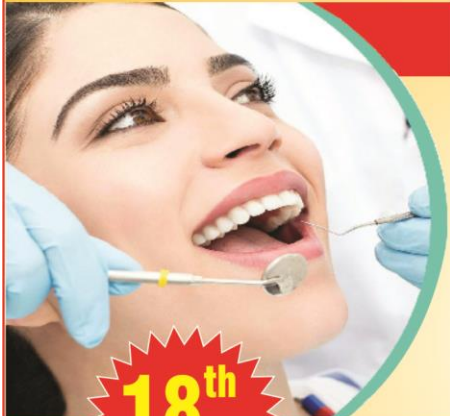

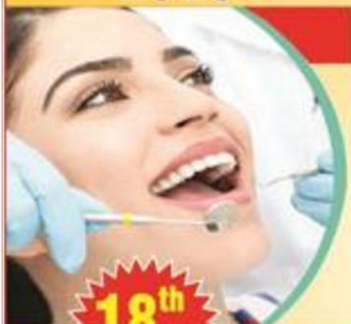
