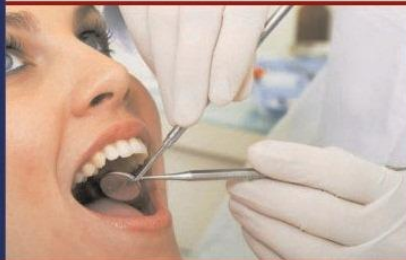

National Eligibility Cum Entrance Test NEET - MDS 2020



National Board of Examinations

(For admission to MDS 2020 Academic Session)

- **NEET-MDS 2020** is a single window entrance examination for all Dental PG courses - 2020 Admission Session. No other entrance examination, either at state or institution level, shall be valid for entry to MDS Courses.
- NBE shall be conducting **NEET-MDS** as a Computer Based Test (CBT) on **20th December 2019** in a single session at all the test centres.

Eligibility Criteria for NEET-MDS 2020

- A candidate for admission to the Master in Dental Surgery course, must possess a recognised degree of Bachelor in Dental Surgery awarded by a university or institute in India and registered with the State Dental Council and has obtained provisional or permanent registration and has undergone compulsory rotatory internship of one year in an approved/recognised dental college. The cutoff date for completion of internship towards determination of eligibility for appearing in **NEET-MDS 2020** shall be **31st March, 2020**

Applying for NEET-MDS 2020

- Candidates can register for **NEET-MDS** through online portal from **11th October, 2019** to **31st October, 2019**. Candidates can choose the exam city through online registration system on first come first serve basis.
- Applicant candidates are required to read the **NEET-MDS 2020 Information Bulletin** thoroughly. The Information Bulletin will be available at www.nbe.edu.in
